## **Objectives and Activities:**

## Objects of the charity are:

To promote general charitable purposes for the benefit of the community of Beira, Mozambique and the surrounding area, and to provide relief from financial hardship and social and/or economic disadvantage and to advance the education of its residents of all ages; and in particular to provide opportunities for the aforementioned residents to participate fully in the life of their community in ways which address and alleviate social and economic disadvantage.

# Summary of main activities in relation to these objects:

The present aims of the trust are:

- to raise funds to finance the completion of the new Youth With A Mission (YWAM) Casa Reom centre for street children in Inhamizua, Beira
- to ensure that the Casa Reom project has sufficient funds to cover the dayto-day running costs.

The trustees agree any development plans with the director of the Casa Reom centre, providing funds and receiving reports to monitor progress.

Some of the day-to-day running costs for the Casa Reom centre are provided by independent donations (not associated with the Casa Reom Trust) to YWAM UK. However, the trustees correspond with YWAM UK to ensure that sufficient funds are provided for running costs by sending Trust funds if necessary. Whilst donors can specify that they want to support regular running costs or the building project, normally funds which are donated to Casa Reom Trust will be allocated by the trustees to either the building project or running costs as is appropriate and required at the time.

# Summary of main activities of the charity during 2019:

In the middle of March 2019, the east coast of Mozambique at the port of Beira experienced catastrophic damage as a result of **Cyclone Idai** which caused massive damage to Beira city and other parts of Mozambique (and parts of Malawi and Zimbabwe) as a result of winds up to 120 mph (205 kph) and severe flooding due to heavy rainfall. Much of 2019 was focused on emergency relief and extensive repairs of the damage to the JOCUM Beira base building (the original site of Casa Reom in Beira city centre) and damage to the site at Inhamizua.

# Cyclone Idai: Damage to Inhamizua Site

The high winds of the cyclone hit Inhamizua in the evening of 14 March 2019. One of the large trees was uprooted and damaged the roof of the dormitory block where all the boys were sheltering but mercifully it fell in a room adjacent to the boys.



As well as the dormitory, there was damage to the roofs and windows of the classroom blocks and the new kitchen/dining room that was under construction had the roof fully peeled off by the high winds.

# Cyclone Idai: Damage to JOCUM Beira City Centre Building

The city centre building (which served as an office, base and staff accommodation) was also massively damaged by the high winds and heavy rain. The roof was blown off and the basement flooded by rain. Some records and the office files and computers were destroyed and the staff accommodation rendered unusable.



Again, mercifully nobody was injured by the damage to the building and the staff were able to be accommodated elsewhere.

Shortly after the visit, Shephen Mbewe (YWAM staff) left from the UK to assist the international relief effort – being able to help with local knowledge, language skills and taking some funds from the Trust to assist immediate repairs and getting aid to those who needed it most. A Cyclone Appeal page was set up and funds of £18,788 were donated towards the relief, repairs and rebuilding.

During this visit, Shephen was able to liaise with the Trustees, JOCUM Beira, YWAM UK, RescueNet and Mercy Air. Funds were used to buy food, materials and tools to facilitate the recovery.

It was apparent that the high building standards of the buildings built using Casa Reom Trust funds at Inhamizua was much higher than other local buildings and consequently the damage was limited largely to roofs and windows – the structure of the buildings remaining intact.

# **Repairs and Rebuilding**

During the remainder of 2019 a phase of rebuilding damaged buildings to "build back better" took place. Great progress was made and the refurbished buildings have benefitted from new windows and doors, as well as a fresh coat of paint making the site a better place to live and learn.



# Trustee Visit

During August and September 2019, Iain Slater was able to visit Casa Reom to meet staff and witness progress in the repair of buildings and the recovery from the cyclone in March. This visit highlighted the importance of visits by Trustees to gain a fuller picture of the status of the project and the response to the challenge of Cyclone Idai.

The site at Inhamizua was found to be in good condition and the staff team had been strengthened by the addition of Nelio and Tabitha who bring experience and skills to the team. The need for improved staff accommodation was evidently becoming a high priority and the repairs to the city centre building were proceeding rather slowly.

A project to build a number of homes for local families was observed and the Trustees agreed that £1,000 from the cyclone appeal funds could be allocated to help these buildings be completed.



lain was also able to visit families being helped and see their desperate situation following the cyclone as well seeing their new houses under construction. By having conversations direct with local people a greater understanding of local conditions was gained.



# Looking Ahead:

# **Impact of Coronavirus Pandemic**

During 2020, Mozambique has suffered a long period of lockdown and since April schools and many businesses have been closed. This has had a number of consequences in terms of interrupted education, diminished career opportunities and disruption to the supply of food and raw materials imported from outside the country. The weakening of the Mozambican metical and supply shortages have led to higher prices in the shops and have been challenging for those young men and women trying to establish homes and livelihoods around Beira.

#### Brief statement of the charity policy on reserves:

Fundraising events are organised by individuals or groups, including trustees of Casa Reom Trust. The Casa Reom Trust may be willing with prior agreement to pay for fundraising expenses, but the events remain the responsibility of the organisers.

The accounts are included below on page 7. The restricted funds are itemised and include money given by individual donors specifically for running costs and money raised for specific projects and purposes such as the Cyclone Idai Appeal.

Receipts in 2019 totaled £43,468 and included:

- £22,250 unrestricted one-off and regular donations
- £18,963 restricted donations
- £2,232 tax refund on Gift Aid Donations
